4.1 Introduction to Comprehensive Plan Services

AJ Fawver presented services offered with Verdunity. Verdunity is a small firm, with a team of 8, and a focus on small rural towns. Verdunity's services include developing a Comprehensive Plan or vision for the community. Commissioner Davis said that updated maps are a high priority for the Town, including zoning, city limits, ETJ, and a map legend.

Ms. Fawver said that they can build a map using GIS data, with the capability to search by address. There are two options for service; on-call basis or per agreed upon contract. Mayor Hamilton would like to see examples of what Verdunity has done for other clients. Commissioner Davis said that they will need time to determine the type of Comprehensive plan needed but would like to see examples first. Ms. Fawver agreed to come back with a proposal/additional information for the Commission to review. No action taken.

4.2 Update for Saddlerock Safari and Winery

A building concept for the Safari reception building was submitted but a Commercial Permit Application is still pending to apply for a building permit. No action taken.

4.3 Eagle Air Parc Addition Re-Plat

Platting Coordinator Joshua Anderson attended and requested that the Commission consider approval to waive the groundwater study. The owners completed the Affidavit form, but Jamie Tierce needs confirmation that the waiver has been approved by the Commission before finalizing the plat review. Commissioner Davis made a motion to approve the waiver for a groundwater study. Mayor Hamilton seconded. The motion passed 2-0. The review of the final plat is tabled until the next Commission meeting on June 17th.

4.4 Valley Spring Plat

Platting Coordinator Theresa McGee attended and said the property currently has a barndominium, is a horse property, and has no plans for additional building or additional water consumption. The owners completed the Affidavit form, but Jamie Tierce needs confirmation that the waiver has been approved by the Commission before finalizing the plat review. Commissioner Davis made a motion to approve the waiver for a groundwater study. Mayor Hamilton seconded. The motion passed 2-0. The review of the final plat is tabled until the next Commission meeting on June 17th.

WHEREAS, on September 28, 2023 the Town Commission of the Town of Brock, Texas (hereinafter, the "Town") adopted a budget for the Town for the fiscal year beginning October 1, 2023 and ending September 30, 2024 as set forth in Town Ordinance No. 2023-006 (the "2023-2024 Annual Budget"); and

WHEREAS, Section 102.010 of the Texas Local Government Code authorizes the Town Commission to make changes in the adopted budget for municipal purposes, and the changes to the budget made herein are for municipal purposes; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAYPEARL, TEXAS:

SECTION 1. The above and foregoing recitals are true and correct and are incorporated herein and made a part of this Ordinance.

SECTION 2. The adopted 2023-2024 Annual Budget for the Town of Brock is hereby amended to include the following line-item adjustments:

- (a) Add new line item under "Revenues" entitled "ARPA Water and Wastewater Study Grant", with a proposed budget amount of \$518,500.00;
- (b) Add new line item under "Expenditures" entitled "ARPA Water and Wastewater Study Project", with a proposed budget amount of \$518,500.00;
- (c) Add new line item under "Expenditures" entitled "Town Clerk", with a proposed budget amount of \$25,000;
- (d) Amend the current line item under "Expenditures" entitled "Misc" by renaming this line item "Community Events", and providing for a proposed budget amount of\$10,000.00; and

(e) Amend the "Expenditures" line item entitled "Newspaper Publications" by amending the proposed budget amount of \$750.00 to \$1,200.00.

SECTION 3. <u>Expenditures.</u> Pursuant to state law, expenditures during the 2023-2024 Fiscal Year shall be made in accordance with the Town's 2023-2024 Annual Budget, as amended herein, unless amended further in accordance with Chapter 102 of the Texas Local Government Code.

ORDINANCE NO. O-2024-003

AN ORDINANCE OF THE TOWN OF BROCK, TEXAS, AMENDING THE COMPREHENSIVE ZONING ORDINANCE TO PROVIDE FOR OUTDOOR SEATING; PROVIDING A PENALTY NOT TO EXCEED TWO THOUSAND AND NO/100 DOLLARS (\$2,000.00); PROVIDING FOR SAVINGS, SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Town of Brock, Texas (hereinafter, "Town") is a general law municipality organized and existing by virtue of the laws of the State of Texas and located within Parker County, Texas; and

WHEREAS, the Brock Comprehensive Zoning Ordinance does not currently provide for "Outdoor Seating Requirements" within the Town; and

WHEREAS, the Town Commission desires to amend the Brock Comprehensive Zoning Ordinance to provide for regulations for outdoor seating in various zoning districts and, further, to provide variance process for said regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF BROCK, TEXAS:

SECTION 1. The of Comprehensive Zoning Ordinance is hereby amended to include an addition section to read as follows:

"SECTION 10.2.19 – OUTDOOR SEATING REQUIREMENTS

Outdoor seating areas may be allowed in conjunction with existing or proposed commercial establishments within Non-Residential and Planned Development Zoning Districts, subject to approval of a Conditional Use Permit pursuant to Section 10.2.12, and in accordance with subject to the following minimum standards.

1. All lights must be arranged and controlled so as to deflect glare or any uncomfortably bright, harsh light away from any nearby residential use.

2. Outdoor seating areas may not generate noise in excess of 45 dB(A) between the hours of 10:00 p.m. and 6:00 a.m. or in excess of 55 dB(A) at all other times.

3. All outdoor seating areas shall be included in the calculation of off-street parking requirements in 10.2.14. The addition of outdoor seating without the requisite minimum number of off-street parking spaces shall be considered a violation of this Zoning Ordinance."

<u>SECTION 2</u>. Any person, firm, or corporation violating any of the provisions or terms of this ordinance shall be subject to the same penalty as provided for in the Comprehensive Zoning Ordinance of the Town of Brock, as heretofore amended, and upon conviction shall be punished by a fine not to exceed the sum of Two Thousand Dollars (\$2,000.00).

<u>SECTION 3.</u> Should any word, sentence, paragraph, subdivision, clause, phrase, or section of this ordinance or of the Comprehensive Zoning Ordinance of the Town of Brock, as amended hereby, be adjudged or held, in whole or in part, to be invalid, voided, or unconstitutional, the same shall not affect the validity of the remaining portions of said ordinances, as amended hereby, which shall remain in full force and effect.

<u>SECTION 4</u>. All ordinances of the Town in conflict with the provisions of this ordinance be, and the same are hereby repealed and all other ordinances of the City not in conflict with the provisions of this ordinance shall remain in full force and effect.

<u>SECTION 5</u>. This ordinance shall become effective from and after its passage and approval and after publication as may be required by law.



Reference: Proposal for Map Services

Ms. Vanesler,

Based on the discussion from the Commission meeting of May 20th, we have drafted this proposal for the Commission's consideration and approval. The Commission indicated a definitive interest in proceeding with the creation of Town maps but was not prepared to move forward with considering a comprehensive plan until additional examples of work could be provided. Those examples were sent over to you via email on May 30th.

SCOPE OF SERVICES

- Task 1 Build a Town boundary map. VERDUNITY (VU) staff will create a static map based upon data provided by the Town of Brock that illustrates the Town's geographic limits and the Town's Extra-Territorial Jurisdiction (ETJ). This map will be created in the form of a shape file. It will be accompanied by a .pdf static file.
- Task 2 Build a base zoning map. VU staff will, with the assistance of the Town of Brock, obtain parcel information for all properties within Brock's limits from the Parker County Appraisal District. *Once obtained*, VU will set up a static base zoning map in the form of a shape file. A .pdf static file will also be provided. *Note: It is expected that the City will help with coordination of obtaining the data. VU will provide a formalized letter of request that the City can utilize, but having a local contact who can keep things moving along is imperative.*
- Task 3 Establish an online map that can be added to the Town's website and update them as needed. VU staff will, once tasks 1 & 2 have been completed, transition that data into a web map and provide code so that it can be embedded into the Town's website. As updates are made to the map, the code will be updated quarterly so that the resulting web map is always up to date.

BUDGET

Invoices will be provided monthly until the work is concluded. The project budget is capped at \$15,000 and invoicing will be based on *actual* hours worked each month by VU, using the billing rate table below.

SCHEDULE AND EXTENSION TERMS

This contract is based on an initial 3-6 month period. It is estimated that this is sufficient time to complete Tasks 1-3, not including the time it takes to obtain the necessary parcel information from the Parker County Appraisal District. The Town may elect to extend the contract further with adjusted cap amounts. Either party may terminate the contract with a minimum of two weeks' notice in writing to the other party. Should the Town wish to extend the contract and add additional tasks (examples include ongoing, on-call services for staff augmentation or map edits), a new proposal will be drafted and executed by both parties.

TERMS OF ENGAGEMENT
