ORDINANCE NO. 2023-003

AN ORDINANCE OF THE TOWN OF BROCK, PARKER COUNTY, TEXAS ORDERING A GENERAL ELECTION TO BE HELD ON NOVEMBER 7, 2023, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) COMMISSIONERS EACH FOR A TERM OF TWO (2) YEARS; DESIGNATING ELECTIONDAY AND EARLY VOTING DATES, TIMES, AND LOCATIONS OF POLLING PLACES; DECLARING A FILING PERIOD; ORDERING NOTICE OF ELECTION TO BE GIVEN AS PRESCRIBED BY LAW IN CONNECTION WITH SUCH ELECTION; AUTHORIZING THE TOWN CLERK TO EXECUTE A JOINT ELECTION AGREEMENT AND CONTRACT FOR ELECTION SERVICES WITH THE PARKER COUNTY ELECTIONS OFFICE TO CONDUCT THE ELECTION; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Town of Brock (hereinafter, "Town") is a general law municipality organized and existing by virtue of the laws of the State of Texas and located within Parker County, Texas; and

WHEREAS, pursuant to Chapter 24 of the Texas Local Government Code, a mayor and two (2) commissioners are elected every two (2) years and said terms currently expire November, 2023.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF BROCK, TEXAS:

SECTION 1. Recitals. The Recitals above are true and correct, are incorporated herein and made a part hereof for all purposes.

SECTION 2. Election Ordered. An election is hereby ordered for November 7, 2023, for the purpose of electing the Mayor and two (2) Commissioners each to serve for a regular two (2) year term. The Mayor shall execute the "Order of General Election" attached hereto as Exhibit A and incorporated herein, establishing the dates, times and polling places for said election, The Order referenced in Section 2 herein shall serve as notice and order of election and shall be posted as required by law.

SECTION 3. Early Voting Polling Places and Election Hours. Early Voting sites and hours for voting by personal appearance for the General Election to be held on November 7, 2023, as conducted by Parker County, Texas are as follows:

SECTION 5. Filing for a Place on the Ballot. Qualified persons may file as candidates by filing an application beginning at 8:00AM, July 22, 2023 and not later than 5:00 PM, Monday, August 21, 2023. Applications may be filed by mail to Town of Brock, 2451 F.M. 1189, Suite B, Brock, TX 76087; by email townclerk@brocktx.net; or in-person with the Town Clerk at 2451 F.M. 1189, Suite B, Brock, TX 76087 Tuesdays and Thursdays during the filing period, from 9:00AM- 4:00PM. Applicants may also contact townclerk@brocktx.net to arrange for other in-person ballot submission times during the filing period stated in this section.

SECTION 7. Election Order and Notice. The Election Order attached hereto as Exhibit A shall serve as notice and order of election, and shall be posted on the bulletin board used to post notice of the Town Commission meetings and on the Town's website as soon as possible after the effective date of this Ordinance, and shall remain thereon until after November 7, 2023. Said Order shall be published in a newspaper of general circulation in the Town at least once, not earlier than the 30th day nor later than the 10th day, before Election Day as provided in Section 4.003(a)(1) of the Texas Election Code. A copy of the published notice that contains the name of the newspaper and the date of publication shall be retained by the Town Clerk as a record of such notice, and the person posting the notice shall make a record of the time of posting, starting date,

and the place of posting, and the person posting the notice shall make a record at the time of posting stating the date and place of posting in accordance with Texas Election Code Section 4.005.

SECTION 8. Election Administrator; Authority to Execute Agreement. The Parker County Elections Administrator shall serve as Elections Administrator for the election. The Elections Administrator shall oversee the appointment of all judges, voting clerks, alternates and other officials and establish reasonable fees as set forth in the Joint Election Agreement and Contract for Election Services. The Town Clerk is hereby authorized to execute a Joint Election Agreement and Contract for Election Services with the Parker County Elections Office for the General Election to be held on November 7, 2023. The Town Clerk shall have further authority to approve any minor modifications as may be necessary in the best interest of the Town. The voting system or systems used by Parker County meeting the standards and requirements of the Texas Election Code, as amended (an electronic voting system, the HART InterCivic Verity DUO Voting System (Version 2.3.1)) is hereby adopted and approved for early voting by personal appearance and by mail and for election day voting.

SECTION 9. Other Action. The Mayor and Town Clerk are hereby authorized to take such further action necessary to complete this election that is not expressly prohibited by law as may be requested by the Election Administrator with the concurrence of the City Attorney.

SECTION 10. Effective Date. This Ordinance shall take effect from and after its passage.
