ORDINANCE NO. 2017-06-12. 1

**AN ORDINANCE OF THE TOWN OF BROCK, TEXAS, RECOGNIZING AND APPROVING THE ORIGINAL MUNICIPAL INCORPORATION BOUNDARIES AND EXTRATERRITORIAL JURISDICTION OF BROCK AS APPROVED BY INCORPORATION ELECTION ON NOVEMBER 8, 2016 AND ACKNOWLEDGING THE BOUNDARIES WILL BE AMENDED; AUTHORIZING A TOWN MAP TO BE PREPARED SHOWING THE ORIGINAL AND AMENDED BOUNDARIES OF THE TOWN AND ITS EXTRATERRITORIAL JURISDICTION; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, an incorporation election was held on November 8, 2016 where the voters approved the incorporation of the Town of Brock as canvassed and approved by the Parker County Commissioners' Court on November 21, 2016, and

**WHEREAS**, the Town of Brock, Texas (the "**Town**" or "**Brock**") is a general law municipal corporation organized and existing by virtue of the laws of the State of Texas and located within Parker County, Texas; and

**WHEREAS**, the Town of Brock desires to accept the original municipal boundaries and acknowledges the boundaries will be amended pursuant to settlement agreement with Weatherford; and

**WHEREAS**, Texas Local Government Code Section 41.001. requires that each municipality shall prepare a map that shows the boundaries of the municipality and of its extraterritorial jurisdiction with a copy to be kept in the office of the secretary or clerk of the municipality; and

**WHEREAS**, Brock desires to prepare a map showing the original boundaries and a map as amended by its settlement agreement with Weatherford which resulted in a discontinuance of sparsely populated area of the Town.

**NOW THEREFORE BE IT ORDAINED BY THE TOWN COMMISSION OF BROCK TEXAS THAT:**

**PART 1.** The recitals above are true and correct and are incorporated and made a part here of for all purposes.

**PART 2.** Brock accepts the original boundaries and recognizes the boundaries shall be amended.

**PART 3.** A map of the original boundaries including extraterritorial jurisdiction, and as amended is required.

**PART 4.** The original map and as amended shall be kept in the office of the Town Clerk.

**PART 5.** Michael M. Ivey, RPLS shall prepare the maps showing the original and as amended boundaries and extraterritorial jurisdiction areas.

**PART 6.** Should any article, section, part, paragraph, sentence, phrase, clause, or word of this ordinance, for any reason be held illegal, inoperative, or invalid, or if any exception to or limitation upon any general provision herein contained be held to be unconstitutional or invalid or ineffective, the remainder shall, nevertheless, stand effective and valid as if it had been enacted and ordained without the portion held to be illegal, inoperative, unconstitutional, invalid, or ineffective.

**PART 7.** This ordinance shall take effect upon its passage.
