ORDINANCE NO. 2017-07-26.1

AN ORDINANCE OF THE TOWN OF BROCK, TEXAS, AUTHORIZING AN ELECTION TO SUBMIT A PROPOSITION TO IMPLEMENT A SALES TAX OF ONE AND ONE-HALF PERCENT (1.5%) WITHIN THE MUNICIPAL BOUNDARIES OF THE TOWN; CONTRACTING WITH THE PARKER COUNTY ELECTIONS OFFICE TO CONDUCT THE ELECTION, AUTHORIZING THE PROVIDING OF NOTICE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Brock, Texas ("Brock") is a general law municipal corporation organized and existing by virtue of the laws of the State of Texas and located within Parker County, Texas; and

WHEREAS, Tex. Tax Code chapter 321, section 401, allows the governing body of a town to call an election by ordinance for a proposition election to adopt a local sales tax.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF BROCK, TEXAS THAT:

SECTION 1. <u>**RECITALS TRUE AND CORRECT.</u>** The above and foregoing recitals are true and correct and are incorporated herein and made a part hereof for all purposes.</u>

SECTION 2. <u>ELECTION CALLED.</u> The Commission calls an election to consider the adoption of a 1.5 percent sales tax within the incorporated city limits of the Town of Brock. The election is to be held on the next uniform election date of November 7, 2017. Brock will contract with the Parker County Elections office to administer said election and the Parker County Courthouse Annex shall serve as the Main Early Voting Place.

SECTION 3. <u>BALLOT LANGUAGE</u>. Pursuant to Tax Code Section 321.404, the ballot shall be as follows: to allow the vote for or against "A sales and use tax is adopted within the City of Brock at the rate of 1.5 percent".

SECTION 4. <u>ELECTION ORDER AND NOTICE.</u> This ordinance shall serve as notice and order of election and shall be posted as required by law.

SECTION 5. EFFECTIVE DATE. This Ordinance shall take effect from an after its passage.
