### ORDINANCE NO. 2021-004

AN ORDINANCE OF THE TOWN OF BROCK TEXAS ORDERING A GENERAL ELECTION ON NOVEMBER 2, 2021, TO ELECT A MAYOR AND TWO (2) COMMISSIONERS EACH FOR A TERM OF TWO (2) YEARS; ESTABLISHING ELECTION DAY AND EARLY VOTING DAY LOCATIONS; DECLARING A FILING PERIOD; ESTABLISHING EARLY VOTING DATES AND TIMES; CONTRACTING WITH THE PARKER COUNTY ELECTIONS OFFICE TO CONDUCT THE ELECTION; AUTHORIZING PROVIDING NOTICE AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the Town of Brock (Brock) is a general law municipality organized and existing by virtue of the laws of the State of Texas and located within Parker County, Texas; and

WHEREAS, pursuant to Chapter 24 of the Texas Local Government Code a mayor and two (2) commissioners are elected every two (2) years and said terms currently expire November 2021.

### NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF BROCK, TEXAS:

<u>SECTION 1. RECITALS TRUE AND CORRECT</u>. The Recitals above are true and correct and are incorporated herein and made a part hereof for all purposes.

### SECTION 2. ELECTION ORDERED.

- (a) An election shall be held for the Town of Brock, Texas on November 2, 2021 to elect persons to fill the offices of Mayor and two (2) Commissioners each to serve for a regular two (2) year term.
- (b) The Commission shall execute the attached "Order Calling the Election" and establishing the dates, times and polling places for said election.
- (c) The Commission previously posted, as required by law, the timeline for applying for a place on the ballot.
- (d) The election shall be administered by the Parker County Elections Office. The Elections Administrator shall serve as the early voting clerk. The Elections Administrator shall as oversee the appointment of all judges, voting clerks, alternates and other officials and establish reasonable fees as set forth in the election services contract.

SECTION 3. ELIGIBLE VOTERS. All residents residing in the incorporated Town of Brock who are registered to vote and meet state election voting requirements are eligible to vote.
